

LEGAL PLANNING – completing your protection and that of your Family...

There are three main strands to Legal Planning for most people, vital for everyone but absolutely essential for couples (married or not) and those with children:

1) Last Will and Testament

Everyone over 18 should have a Will so their assets go to the right people, rather than come under the (unfair) Rules of Intestacy – your money will be shared out in most unexpected ways! Lack of a Will (like out of date or ill considered Wills) can lead to lots of tax, family rows, even financially and emotionally expensive Court action. Married partners can be made homeless or separated from children who are not legally theirs. Don't leave the Courts to decide who would look after your children! Write a Will and secure the future as you would wish it to be, even if you can't share it. Wills may also:

- **just having Wills can save substantial IHT for married/ registered couples.**
 - protect assets from creditors including the biggest of all - Community Care Tax (Nursing Home Fees) (Local Authorities to repossess and sell upwards of 70,000 homes every year – rising) leaving just £11,500 for the family. A simple accident or illness can land you in long term care at any age.
 - protect your children against remarriage of the surviving parent resulting in your assets going to *their* new partner instead of to your children, without causing problems.
 - create Trusts to benefit and protect children, grandchildren etc
 - give flexibility to your executors to benefit family members who really need help
 - IHT Protection for unmarried couples
 - **The Family Bank Will can help secure your family through the generations for up to 80 years**
- ### 2) Lasting Powers of Attorney (LPA)

NO ONE has the right to manage your finances or personal welfare even if you become mentally incapable through sickness, accident or sheer old age – not even your husband or wife – **UNLESS** you have written an LPA. The only alternative is for a friend or relative to apply to be appointed as your RECEIVER at a cost of £580 or so + legal (possibly substantial) legal fees + significant ongoing costs. An LPA costs less and allows YOU to decide, in advance, who you would like to look after your money (the Property and Affairs LPA), and your welfare (the Personal Welfare LPA) if you become unable to do so yourself. Everyone over 18 should ideally have both LPAs – Personal Welfare and Property and Affairs.

Neither of the LPAs can be used until they are registered at a cost of £150 each, so we offer a General Power of Attorney as a more economical substitute to early registration, but they must NOT be used as a substitute for an LPA (Property & Affairs) as they are no longer valid on mental incapacity and a Receiver would need to be appointed. Similarly, an LPA Personal Welfare cannot be used while you retain mental competence, but an Advance Decision (a very much cut down and simplified version) ONLY covers Medical matters but does not require registration, so can be used in the event of emergency.
